Paying Fines

If you have been charged with one of the offenses listed below and would like to plead guilty and pay the fine and court costs without having to appear in court, you may sign the citation and return by mail along with the full amount, to the address indicated. If your charge is not listed below and/or you wish to plead NOT GUILTY, you **must** appear on the indicated date, time and place as listed on your citation.

Court Appearance Required Citations

If your citation requires a court appearance, you must appear in court on the date listed on the citation you received. You will appear before the Municipal Prosecutor and Municipal Judge and enter a plea on the charge. If you plead guilty, the judge will determine your fine amount and you will be able to pay the fine at this time. If you plead not guilty, your trial will either be held that day or will be continued to the next court date. If you do not know whether or not your citation requires a court appearance, you may contact the Woodstock Municipal Court or you may check the fine schedule. If you do not see your citation listed on the fine schedule, please contact the Court Clerk office at 205-938-9790.

PAYMENT SCHEDULES ARE AVAILABLE. If you need to be placed on a payment schedule, this does require a court appearance.
